## Information We Collect

The personal information that we request from you, as well as the reasons for its collection, will be clearly stated at the point when we ask for your personal information.

If you contact us directly, we may receive additional information about you, such as your name, email address, phone number, the contents of the message, and/or any attachments you choose to send us, along with any other information you provide.

When you register for an Account, we may ask for your contact information, including items such as your name, company name, address, email address, and telephone number.

## How We Use Your Information

Log Files

Meibotan follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies employ this practice as part of their analytics services. The information collected by log files includes internet protocol (IP) addresses, browser type, Internet Service Provider (ISP), date and time stamps, referring/exit pages, and possibly the number of clicks. This information is not linked to any personally identifiable information. The purpose of this information is to analyze trends, administer the site, track users' movements on the website, and gather demographic information.

Cookies and Web Beacons

Like any other website, Meibotan uses 'cookies.' These cookies are used to store information, including visitors' preferences and the pages of the website that the visitor accessed or visited. The information is used to optimize the users' experience by customizing our web page content based on visitors' browser type and/or other information.

Google DoubleClick DART Cookie
